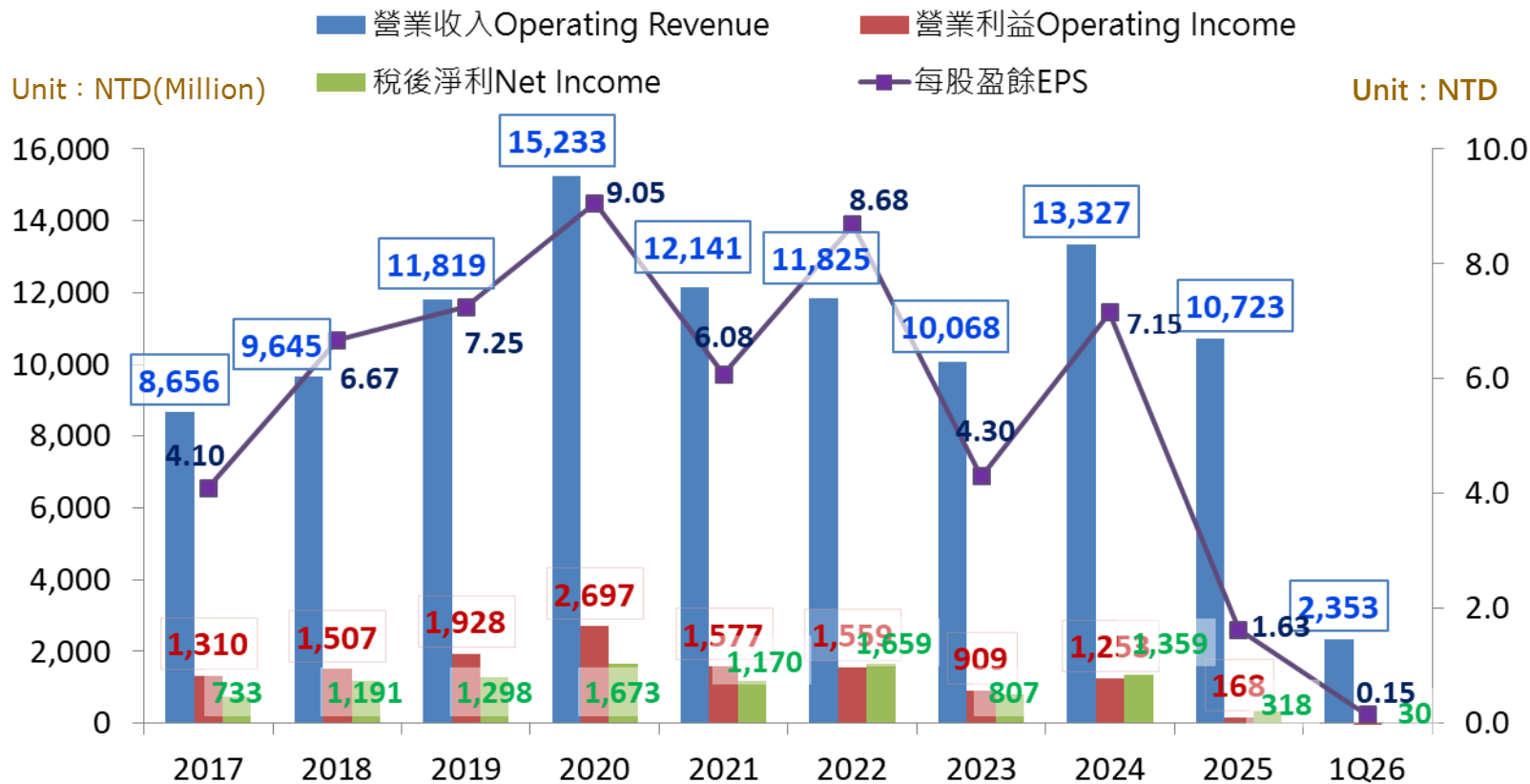

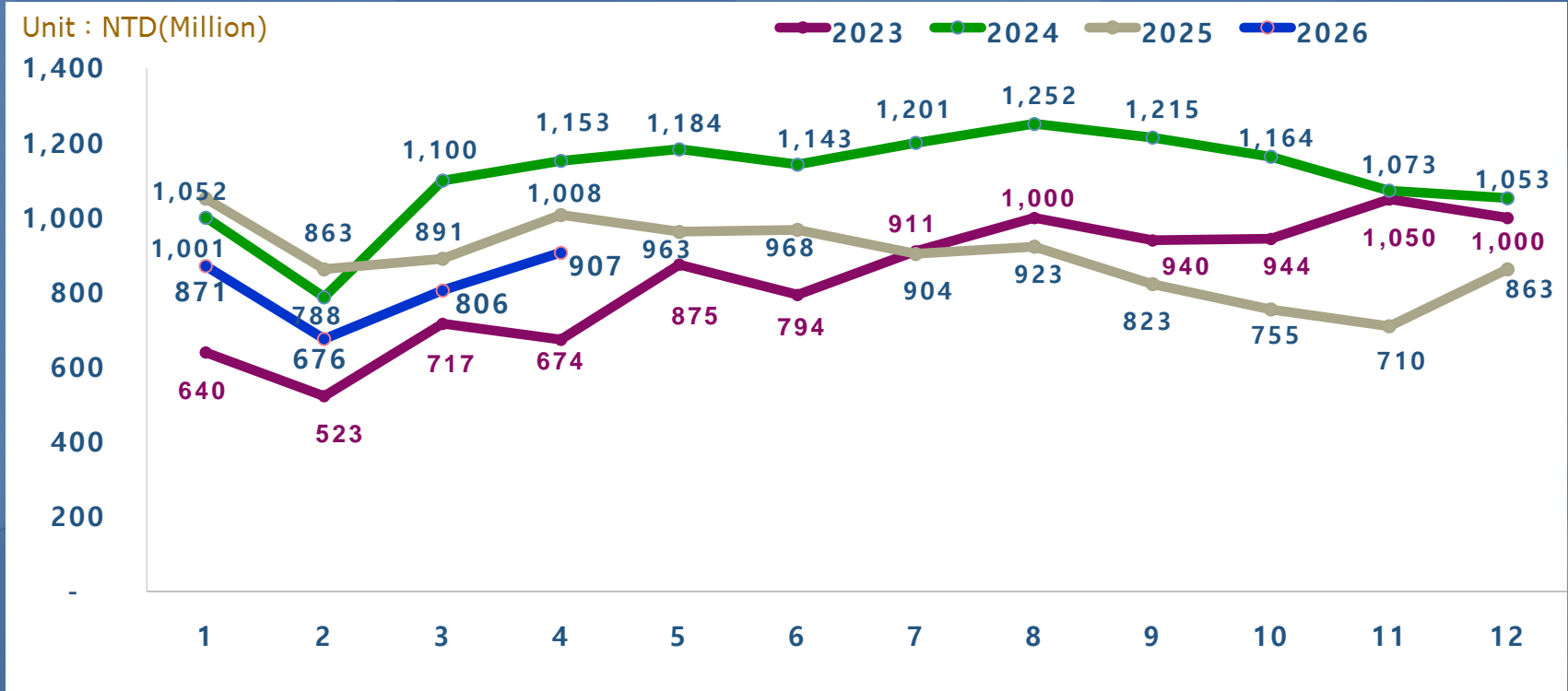
營收狀況 Consolidated Revenue SZS
